## **Explanation of Responses:**

- 1. On 08/04/2008, Reporting Person was awarded restricted stock units (RSUs). Each RSU represents a contingent right to receive one (1) share of VeriSign common stock once vested. Twenty-five percent (25%) of the grant vests on the first anniversary of the date of grant and thereafter as to twenty-five percent (25%) of the granted RSU on each subsequent annual anniversary date of the date of grant, subject to necessary withholding for applicable taxes.
- 2. Reporting Person's total direct holdings disclosed in Table I, Item 5, under Amount of Securities Beneficially Owned Following Reported Transaction(s) include 532 shares acquired under the VeriSign, Inc. 1998 Employee Stock Purchase Plan on July 31, 2008.
- 3. Twenty-five percent (25%) of the total options granted vest and become exercisable on the first anniversary of the date of grant and thereafter with respect to 6.25% of the shares each quarterly anniversary of the date of grant until fully vested.
