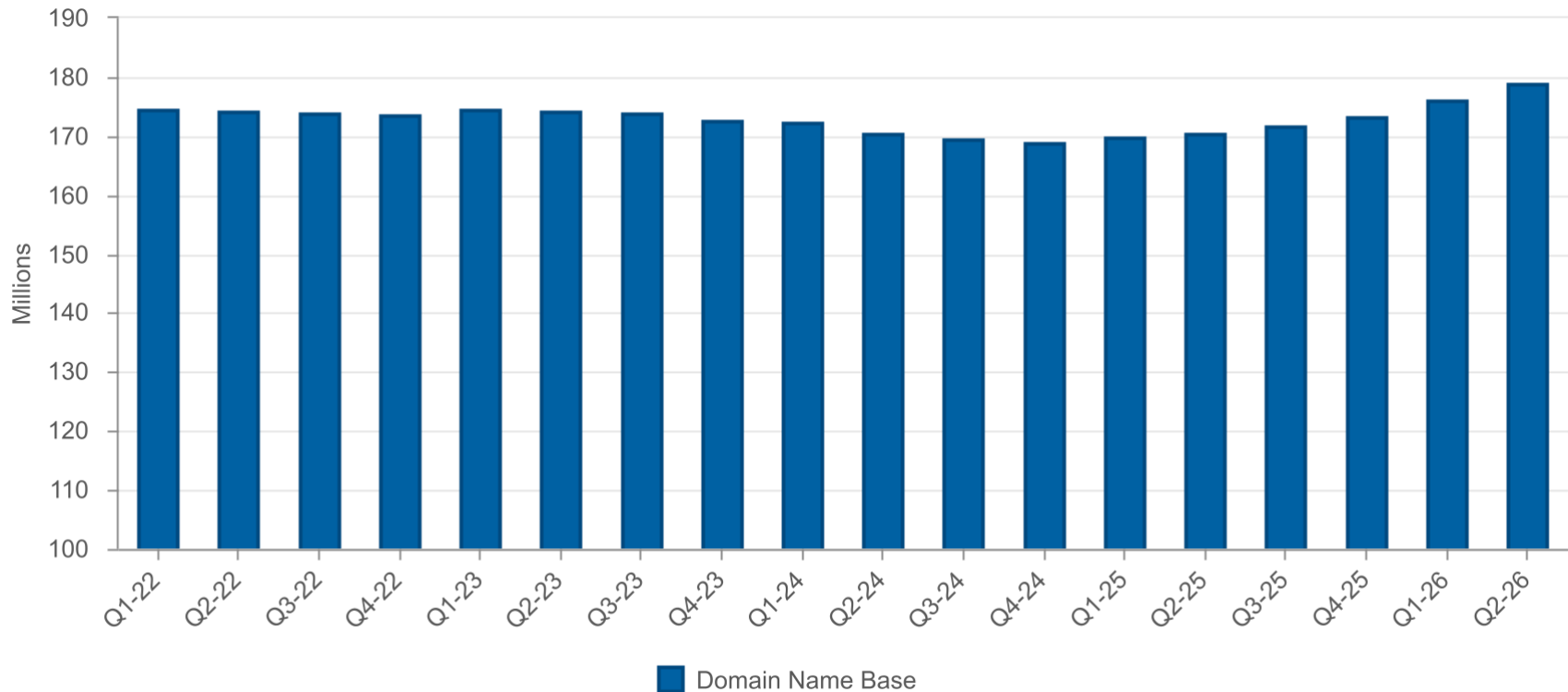

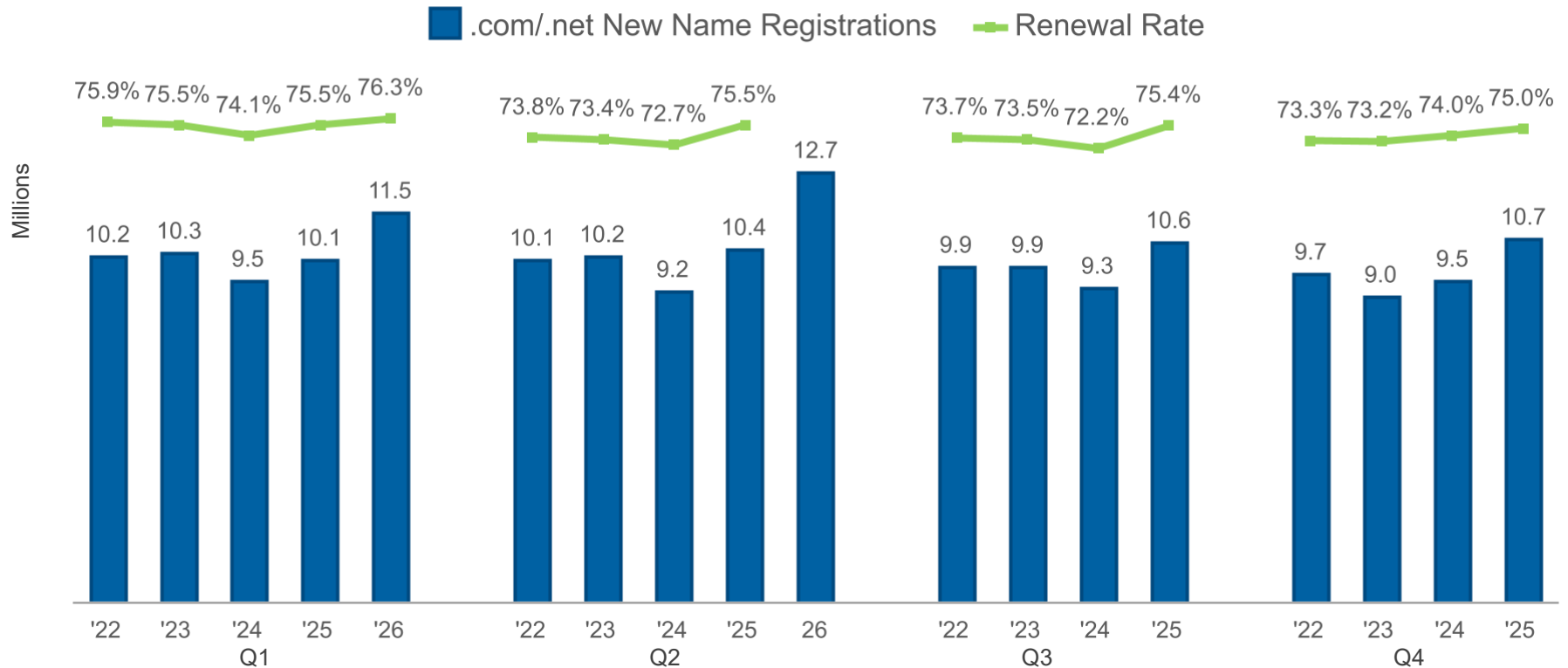

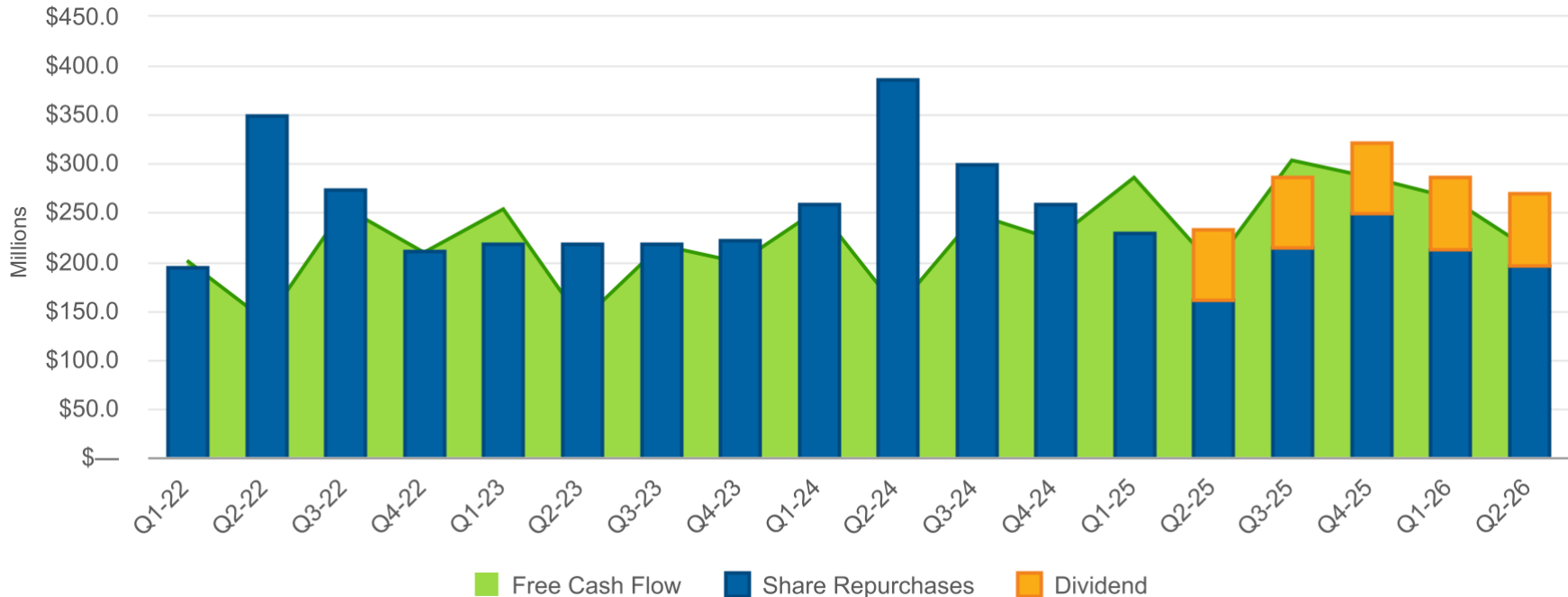

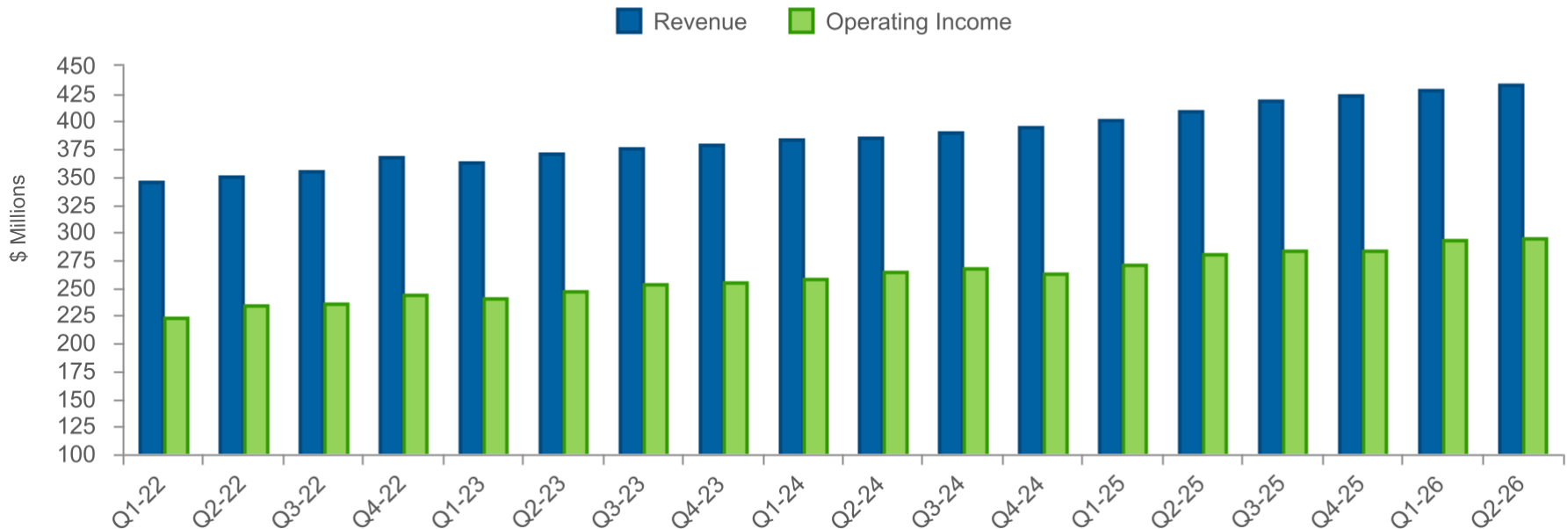

Non-GAAP Reconciliation

Management believes that this non-GAAP financial measure supplements the GAAP financial measures by providing investors with additional information that allows them to have a clearer picture of Verisign's operations and financial performance and the comparability of Verisign's operating results from period to period. The presentation of this non-GAAP financial measure is not meant to be considered in isolation nor as a substitute for financial measures prepared in accordance with GAAP.
